**PL/026/24 - TO CONSIDER AND COMMENT ON PLANNING APPLICATIONS:**

**24/0655/FUL - 3 ARCADIA ROAD CANVEY ISLAND ESSEX SS8 7SP - THE USE OF C3 DWELLINGHOUSE AS AN OFSTED REGISTERED CHILDREN'S CARE HOME C2 (RESIDENTIAL INSTITUTION) PURSUANT TO THE CHILDREN'S HOME REGULATIONS 2015 AND CARE STANDARDS ACT 2000, FOR THREE CHILDREN RECEIVING CARE 24/7 BY UP TO TWO CARERS ON A SHIFT PATTERN BASIS, INCLUDING CONVERSION OF GARAGE TO HABITABLE SPACE.**

Members discussed the planning application submitted and **RESOLVED** to object to the proposed development for the following reasons:

- The committee questioned the need for yet another children's home.
- Castle Point Borough Council Planning Officer has advised the Chairman of Planning for Canvey Island Town Council that they have informed Essex County Council that there is no more need for Children's Care Homes on Canvey Island.
- Due to the emphasis made from central government on the need for residential properties on Canvey Island the committee has raised concerns that this development is removing an existing residential dwelling and replacing it with a business where there are potentially other empty facilities available.

**24/0702/FUL - 174 WAARDEN ROAD CANVEY ISLAND ESSEX SS8 9BE - CHANGE OF USE OF C3 DWELLINGHOUSE TO A CHILDREN'S CARE HOME (USE CLASS C2) FOR A MAXIMUM OF 3 CHILDREN, AGED 8-17 YEARS, WITH CARERS SLEEPING OVERNIGHT, WORKING ON ROTA BASIS.**

Members discussed the planning application submitted and **RESOLVED** to object to the proposed development for the following reasons:

- The committee questioned the need for yet another children's home.
- Castle Point Borough Council Planning Officer has advised the Chairman of Planning for Canvey Island Town Council that they have informed Essex County Council that there is no more need for Children's Care Homes on Canvey Island.

- Due to the emphasis made from central government on the need for residential properties on Canvey Island the committee has raised concerns that this development is removing an existing residential dwelling and replacing it with a business where there are potentially other empty facilities available.
- The application advises of 24-hour nursing, lightening of the property all night could have an adverse effect on the neighbouring property.

**24/0710/FUL - 5 BORRETT AVENUE CANVEY ISLAND ESSEX SS8 9EB - DEMOLISH EXISTING BUNGALOW AND GARAGE AND CONSTRUCT PAIR OF SEMI-DETACHED DWELLINGS WITH ASSOCIATED FACILITIES.**

Members discussed the planning application submitted and **RESOLVED** there was no planning reason for objection, however, felt that the new development is not in keeping with the street scene.

The committee did feel that this development was a great starter home for a family.
