PL/12/25 - TO CONSIDER AND COMMENT ON PLANNING APPLICATIONS:

25/0695/FUL - 1 HIGH STREET CANVEY ISLAND ESSEX SS8 7RA - DEMOLITION OF EXISTING BUILDING AND ERECTION OF 4 STOREY BUILDING COMPRISING OFFICE (CLASS E), UNDER-COFT PARKING TO GROUND FLOOR AND 24NO. SELF-CONTAINED FLATS (CLASS C3)

Members discussed the planning application submitted and **RESOLVED** to object to the proposed development for the following reasons:

- The committee felt this development would completely dominate the town centre skyline.
- Concerns were raised due to the closeness of the new build to the substation.
- There is a lack of green space for a new build of this size.
- The application has inadequate number of parking spaces showing 17 parking spaces for 24 flats.
- This development is detrimental to surrounding businesses, due to the heavy impact on the one-way system during the building process.
