PL/002/22 - TO RECEIVE DECLARATIONS OF INTEREST IN ITEMS ON THE AGENDA.

Cllr C. Sach declared a non-pecuniary interest and didn't speak regarding planning application 22/0665/FUL due to already making representation on this application with Castle Point Borough Council

PL/003/22 - TO APPOINT A VICE CHAIRMAN TO THE COMMITTEE FOR 2022/23

Cllr S Sach nominated Cllr E Harvey as Vice Chairman and the nomination was seconded by Cllr N Harvey. There were no other nominations therefore Cllr E Harvey was appointed as Vice Chairman for 2022/23.

The minutes of the committee meeting held on the 25th April 2022 were signed and CONFIRMED as a true record.


PL/006/22 - TO CONSIDER AND COMMENT ON PLANNING APPLICATIONS:

22/0665/FUL - GARDEN WORLD PLANTS LTD CANVEY ROAD CANVEY ISLAND ESSEX SS8 0QD-DEMOLITION OF EXISTING BUILDINGS AND CONSTRUCTION OF RESIDENTIAL CARE HOME COMPRISING OF 55NO. UNITS WITH PROPOSED CROSS-OVER BOUNDARY TREATMENT

Members discussed the planning application submitted and **RESOLVED** to object to the proposed development for the following reasons:

- Concerns were raised that this development had already started.
- The site appears overdeveloped
- This location was not appropriate for this type of dwelling due to it being on the out skirts of an industrial estate.
- Apprehension was expressed that noise and air pollution fumes from the busy road could possibly permeate the care home building.
- Concerns were raised that there was no access or crossing for disabled or mobility scooters and only an inadequate narrow footpath on the opposite side of the road.
- The committee raised a concern that if the residents on the ground floor have mobility issues and lifts couldn't be accessed in a flood how would they get to the second floor.
- Members felt that this three-storey development would overshadow the existing houses in the location.
- Inadequate parking provision for staff, health care professionals and for any potential visitors.

- Concerns were raised that the applicant has confirmed on the planning application that it is unknown where the foul sewage will be disposed of.
- The entrance and exit for large vehicles to this development by means of Canvey Road will impede traffic movement on an already busy road.
- The method statements advise that's there an area for cleaning the contractors' wheels, but this can't be found on the applications map.
- Concerns were raised of contradictions in the method statement.
- The chairman asked the location of this development falls within Natural England's designated RAMS site.
