


Disclosable Pecuniary Interests

Members are required to register not only their own interests under this heading but also those of their husband or wife, civil partner or of any person with whom they are living as if husband and wife or as civil partners when such interests are known by them

<u>Employment, office, trade, profession or vocation</u> 1. Your employment, office, trade, profession or vocation carried on by you or those persons referred to above for profit or gain (includes any payments or benefits in kind which are subject to Income Tax).	
<u>Sponsorship</u> 2. Any payment or provision of any other financial benefit (other than for your authority) made or provided within the last 12 months in respect of expenses your have incurred in carrying out your duties as a member, or towards	

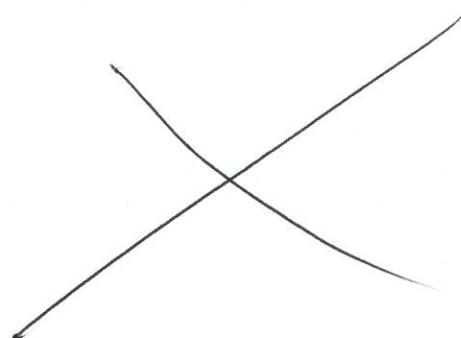

<p><u>Contracts</u></p> <p>3. A description of any contract for goods, services or works made between your authority and you or the persons referred to above (or a body in which you or they have a beneficial interest) and which has not been fully discharged</p>	
<p><u>Land</u></p> <p>4. Any land in your authority's area in which you have a beneficial interest</p>	<p>31 munsterburg Road CTI</p>
<p><u>Licences</u></p> <p>5. Any land in the authority's area for which you or the persons referred to above have a licence (alone or jointly with others) to occupy for a month or longer</p>	
<p><u>Corporate Tenancies</u></p> <p>6. Any tenancy where to your knowledge the landlord is your authority and the tenant is a body in which you or a person referred to above has a beneficial interest</p>

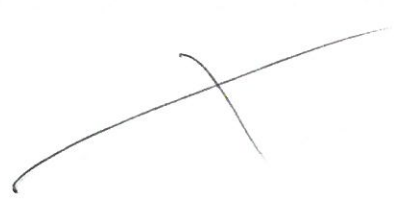
7. The name of any person or body in which you or a person referred to above has a benefit interest in securities of that body where:
- (a) that body to your knowledge has a place of business or land in the area of your authority; and
 - (b) either-
 - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issue share capital of that body; or
 - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or a person referred to above has a beneficial interest exceeds one hundredth of the total issue share capital of that class






Other Pecuniary Interests
