

Registerable Non-Pecuniary Interests

Members are only obliged to register their own interests under this heading and do not need to include the interests of husbands/wives/civil partners or others

 - to which you have been appointed or nominated by your authority
 - b. exercising functions of a public nature
 - c. directed towards charitable purposes
 - d. one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union)

I also acknowledge that it may be a breach of the Code of Conduct to:-

- (1) omit information that ought to be given in this notice;
- (2) provide information that is materially false or misleading;
- (3) fail to provide written notification to the authority's monitoring officer of any change in my interests contained in this notice. The 28 days of my becoming aware of such change of circumstances
