Except for the matters reported below, on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no other matters have come to our attention giving cause for concern that relevant legislative and regulatory requirements have not been met.

The Annual Return was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when submitting next year's Annual Return. :

- The figures in Section 2, Boxes 3, 7, and 8 of the prior year comparative column do not agree to the figures stated in the prior year external auditor report. The figures in Boxes 3, 7 and 8 for the prior year should read £25,730, £385,812 and £381,298 respectively. As a result of this the figures in the current year Boxes 1 and 3 should read £385,812 and £25,230. This was due to interest income of £247 being omitted from the prior year Box 3.
- Section 2, Box 9: Information received from the smaller authority indicates that assets purchased during the prior year have not been included in prior year Box 9.
